

## Information under Article 13 of Legislative Decree 196/2003

---

### ***Dear Interestead,***

inform you that Legislative Decree number 196, June 30, 2003 ("Code regarding the protection of personal data") provides for the protection of persons and other subjects regarding of personal data. Under legislation, this treatment will be based on principles of correctness, lawfulness and transparency and the protection of your privacy and your rights. Under Article 13 of Legislative Decree number 196/2003, we provide the following information:

**1. The data you provide, including those relating to your credit card, will be processed in order to develop, register and make a booking request for the drafting and delivery of the notification, as well as for purposes of tax and accounting.**

**2. The data will be as follows: using computer data processing and collected through manual preparation of forms.**

3. The conferment of data is compulsory and the refusal to provide such data may lead to failure or partial completion or continuation of the existing relationship between the parties.

4. The data can be communicated to public (public security agencies for example) and individuals (professionals, service centers, for example) if pursuant to a provision of law or regulation and enforcement of obligations conferred upon them and their employees in as being responsible for processing, properly informed and educated of the requirements and measures to be taken with regard to privacy, and will be retained for the periods required by applicable law.

6. The Responsible is: **EVA CARUSO (GIA' TITOLARE)**

7. At any time you exercise your rights against the owner of the above, under Article 7 of 196/2003, which for your convenience reproduced in whole:

1. You have the right to obtain confirmation of whether or not personal data concerning him, even if not yet recorded, and their communication in intelligible form.

2. You have the right to obtain information:

- a) the origin of personal data;
- b) the purposes and methods of treatment;
- c) the logic applied in case of treatment with electronic instruments;
- d) the identity of the owner, and the representative appointed under article 5, c. 2;
- e) subjects or categories of persons to whom personal data may be communicated or who may become aware of as designated representative in the State, managers or agents.

3. You have the right to obtain:

- a) updating, rectification or, when interested, integration of data;
- b) erasure, anonymization or blocking of data processed unlawfully, including those which are not needed to be kept for the purposes for which data were collected or subsequently processed;
- c) certification that the operations in letters a) and b) have been disclosed, including their contents, those to whom the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate to the protected right.

4. You have the right to object, in whole or in part:

- a) for legitimate reasons the processing of personal data for purposes of sending advertising materials or direct selling or for carrying market research or commercial communication.
